# Conservation Land Aerial



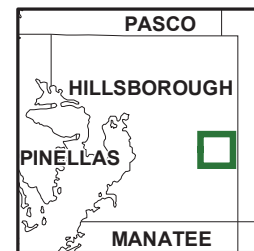
# Alafia River Corridor Map
